
Mangrove trimming regulations among the four barrier island cities

When mangroves are removed these are the consequences

- Sever Erosion
- Loss of fertile sediments
- Lack of filtration from toxins
- Decimation of plant and animal life



There are very few cities and counties that have local ordinances to protect mangroves The delegation of the mangrove program is authorized under section 403.9324 of the Florida statutes. The following local governments have been delegated the authority to implement the Mangroves Trimming and Preservation Act. Questions regarding trimming in a delegated area should be directed to the responsible agencies below.

FDEP requirements for local enforcement

• To receive delegation, a local government must demonstrate that it has sufficient resources and procedures for the adequate administration and enforcement of a delegated mangrove-regulatory program.

• This subsection does not preclude a delegated local government from imposing stricter substantive standards or more demanding procedural requirements for mangrove trimming or alteration outside of riparian mangrove fringe areas.


- Held meetings with the contact in Holmes beach (Chad Minor) last week

- Have read FDEP regulations and have contacted FDEP for guidance


Next Steps

- Establish Interlocal agreements with all four cities
- Define guidelines, administrative and enforcement regulation across all four cities to provide continuity
- Agreement on fine amounts that are enforceable and applicable and equal to the offense or offenses
- Meet educational requirements for enforcement and administrative guidelines
- Communication protocols between cities for real time actionable interception of possible violations
